  - The panel members discussed about introduction of Research programme of M. Phil. as per norms provided by the University of Madras. Further they discussed about the proceedings for admission process of the students. The following candidates were eligible to apply M. Phil guide ship:

The panel Members suggested to delete some portion from Income Tax Law and Practice - I, i.e. Deduction u/s 80c in the V Semester and recommended to add the same portion into the VI semester in Income Tax Law and Practice – II along with Deduction u/s 80C to 80URegulations and Syllabus for B.Com.

- The panel members suggested to implement new regulation related to the syllabus of Business Taxation. So the members recommended introducing Basics of GST for IV semester of B.com degree.
- The panel members suggested to include new paper Corporate Laws for II semester M.Com degree instead of Marketing of services.
- The Board of Studies members discussed about the difficulties faced by the students learning simplex methods in Elements of Operation research for B.Com IV Semester and also they recommended excluding MM approach.
- The following MOOC Papers are equivalent to some of our elective papers in syllabus of B.Com course in the BOS. Changes are made according to the feedback on curriculum given by the students, alumni and other stakeholders:
  - In MOOC Courses through SWAYAM offered Introduction to GST i) course which is equivalent to our PG paper Basics of GST.
  - In MOOC Courses through NPTEL offered Total Quality Management ii) course, this is equivalent to our PG paper TQM.
